Fund objective

Rising Rates Opportunity 10 ProFund seeks daily investment results, before fees and expenses, that correspond to the inverse (-1x) of the daily price movement of the 10-Year U.S. Treasury Note. The Fund does not seek to achieve its stated investment objective over a period of time greater than a single day.

Fund performance and index history²

The Rising Rates Opportunity 10 ProFund seeks daily investment results, before fees and expenses, that are -1x the daily price movement of the most recently issued 10-Year U.S. Treasury Note (the "Note") **for a single day**, not for any other period.

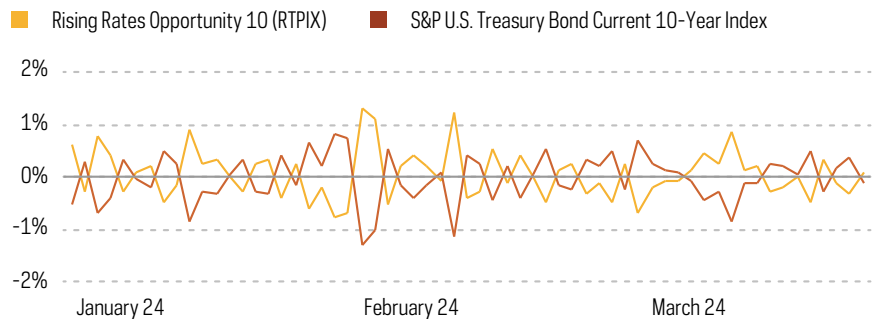

Uses for inverse exposure

Common uses for inverse exposure include:

- Helping to hedge against declines
- Seeking to profit from declines
- Underweighting exposure to a market segment

Many ProFunds routinely employ leveraged investment techniques that magnify gains and losses, and result in greater volatility in value. Each geared (leveraged or inverse) ProFund seeks a return that is a multiple (e.g., 2x, -1x) of the return of an index or other benchmark (target) **for a single day**. Due to the compounding of daily returns, geared ProFunds' returns over periods other than one day will likely differ in amount and possibly direction from the target return for the same period. These effects may be more pronounced in funds with larger or inverse multiples and in funds with volatile benchmarks. Investors should monitor their ProFunds holdings consistent with their strategies, as frequently as daily. For more on risks, please read the prospectus.
