- Overweighting a market segment without additional cash

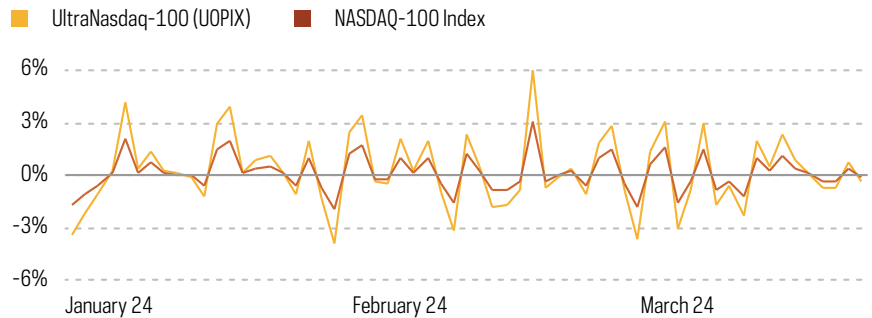

## Daily return during 1Q 2024


